JUNE 4, 2024

Board convened at 9:00 a.m. Present: Chairman Robert Marmon, Commissioner Jamee Hansen and Commissioner Andy Gates.

Tami Aberle, County Health Nurse, met with the Board. She distributed information on "Credible Mind". A one stop shop for mental well-being resources. This free program is made available through First District Health Unit.

Correspondence addressed to the Board's attention was reviewed and discussed. Officers reports were approved as presented.

Sean Mattern, Road Supervisor, met with the Board. The crew has moved the two Park lawn mowers to the Mohall Shop. The lawn mowers are up for sale. Sean has removed the load restrictions as of June 3, 2024. The rock for the Park Bar was delivered and the old coolers were hauled to Earth Recycling at Glenburn. Sean will be moving the 1,000 gallon fuel tank from the Mohall Shop to the Tolley Shop. He will also order gravel for County Roads #11, 15, 7 & 9.

At 10:00 a.m. the meeting was opened for equalization purposes. Tax Director Robin Stark met with the Board to discuss and review the townships' and cities' valuations. Robin noted that the valuations have been approved by the respective township boards and city councils. Moved by Comm. Gates, second by Comm. Robin also discussed an application from a tax payer for inundated lands near Tolley. She will research the process.



Sean has ordered gravel for several County roads. The Board discussed doing some striping on County pavement. They also discussed getting a GPS tracking system for all road department vehicles.
