

RENVILLE COUNTY COMMISSIONERS' PROCEEDINGS
FOR THE MONTH OF MAY 2021

MAY 4, 2021

Board convened at 9:00 a.m. Present: Chairman Robert Marmon, Commissioner Arnold Langehaug and Commissioner William Stanley.

Sean Mattern, Road Supervisor, met with the Board. The Volvo truck as been repaired. The crew has been working on the west access road into the Mouse River Park. They have also been working to fill a large hole by the box culverts on CR#20.

Moved by Comm. Stanley, second by Comm. Langehaug to replace lost warrant #138912 in the amount of \$75.90 for Marty Owens. Motion carried by unanimous vote of aye.

Moved by Comm. Stanley, second by Comm. Langehaug to approve the application for a grant from Garrison Diversion to build a gazebo in the South Camping Unit of the Mouse River Park. The grant amount is \$2,075.00 Motion carried by unanimous vote of aye.

Correspondence addressed to the Board's attention was reviewed and discussed. March payroll and officers reports were reviewed and filed. Travel requests were approved as presented.

Moved by Comm. Langehaug, second by Comm. Stanley that the minutes of April 2021 be approved as presented. Motion carried by unanimous vote of aye.

Moved by Comm. Langehaug, second by Comm. Stanley to approve the 2020 General Purpose Financial Statements as presented. Motion carried by unanimous vote of aye.

The Second Amendment Preservation Act was discussed. Moved by Comm. Marmon, second by Comm. Stanley to pass the following resolution in favor of the Preservation Act:

Resolution 2021-7

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
THE COUNTY OF RENVILLE, NORTH DAKOTA AS FOLLOWS:

WHEREAS, certain legislation introduced in past sessions of the North Dakota Legislative Assembly, and certain legislation introduced in the current session of the United States Congress could have the effect of infringing on the rights of law-abiding citizens to keep and bear arms, as guaranteed by the Second Amendment of the United States Constitution; and,

WHEREAS, the Renville County Citizens are concerned about the passage of any bill containing language which could be interpreted as infringing on the rights of the citizens of Renville County to keep and bear Arms; and,

WHEREAS, the citizens of Renville County expect, the Board of Commissioners will express its commitment to protect the rights of the citizens of Renville County; and,

WHEREAS, the citizens of Renville County expect, the Renville County Board of

Commissioners, will express opposition to any law that would unconstitutionally restrict the rights, under the Second Amendment, of the citizens of Renville County to keep and bear Arms; and,

WHEREAS, the citizens of Renville County expect, that the Renville County Board of Commissioners will, express its intent to stand as an Advocate County for Second Amendment rights and to oppose, within the limits of the Constitution of the United States and the State of North Dakota, any efforts to unconstitutionally restrict such rights.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF RENVILLE COUNTY, NORTH DAKOTA:

That the Board of Commissioners hereby declares that any such federal act, laws, orders, rules and regulations which infringe on the people's right to bear arms as guaranteed by the Second Amendment to the United States Constitution or the North Dakota Constitution shall be invalid in Renville County, shall not be recognized in Renville County and shall be considered null and void with no effect in Renville County including but not limited to:

1. Any tax levy, fee, or stamp imposed on firearms, firearm accessories, or ammunition not common to all other goods and services which could have a chilling effect on the purchase or ownership of those items by law-abiding citizens;
2. Any act ordering the confiscation of firearms, firearm accessories or ammunition from law-abiding citizens; and

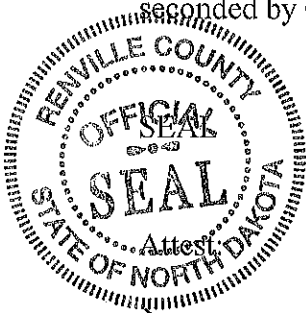


