The Board reviewed a memo to be sent out to all employees regarding sales tax reimbursement and the use of the County's online ordering accounts.

Kristy Titus, DES Coordinator, met with the Board. She discussed the EMPG grant she receives through the State. The Board also discussed the proposed 60/40 salary split with Bottineau County.

County Sheriff, Roger Hutchinson, met with the Board to discuss his proposed 2026 budget. The Board would like him to reevaluate how his deputy salary positions are funded for 2026.

Bethany Gates, County Agent, discussed her proposed 2026 budget with the Board. She also informed the Board of her Field Days event which is July 24th.

Danielle Petersen, Recorder, discussed her requests for the 2026 budget. She had asked to purchase benches for the courtroom. The cost could be shared with the Court system grant program. The Board asked her to compile a prioritized list of needs and wants for the courtroom. There are some electrical and accessibility issues in the courtroom currently. Danielle gave the Board a tour of the courtroom to see the areas of concern. She also requested \$3,000.00 in her travel budget to attend a conference in Virginia Beach in 2026 as part of the PRIA board she is a member of. The Board will look at the travel request and the benches request at the next meeting. Danielle told the Board she is in need of plat cabinets for the Recorder's office. They asked her to gather information on the cabinets and get back to them. She has funds in her Document Preservation fund to help with the cost.


